**RESOLUTION ADOPTING AND PROPOSING ELECTOR APPROVAL OF AN AMENDMENT TO THE CITY CHARTER FOR LEVY OF ADDITIONAL PROPERTY TAX AT THE MAY 2, 2023 SPECIAL ELECTION TO SUPPORT FIRE SERVICES, POLICE AND LAW ENFORCEMENT SERVICES AND FIRST RESPONDER SERVICES**

Councilmember Fitzgerald moved, seconded by Councilmember Postler, that the above Resolution be adopted.

Councilmember Vanderwood moved, seconded by Councilmember Postema, to amend the Resolution to have a 5 year sunset. The subsection to increase property taxation for public safety would expire on June 30, 2028.

Motion carried: 5 Yeas 1 Nay (Bolt)
